Eligibility

The contest is open to all teens (13 year old to 19 year old). Students may submit as many designs as they wish during the contest. Participation in the promotion/contest constitutes entrant's full and unconditional agreement to and acceptance of official rules. Parental permission is required.

Design entries must include the following:

1. "Walk 4 Teens" and/or "Brandon's House Counseling Center"
2. Design highlighting Walk 4 Teens theme "Walking for a brighter future."
3. A maximum of 3 colors (not including shirt color, which you can suggest too)
4. Final artwork:
 1. Files should be high res vector file, AI or jpg
 2. Maximum area to fill for printing on t-shirt is 13x18" max (front side only)
5. Entries must be emailed to staff@brandonshousein.com. Entries must include completed entry form, media release, and design file.

Process/Timeline Deadline for submission: April 2, 2021 (midnight ET)

You must complete the entire application. Entries will not be accepted if application is incomplete.

Selection of top three submissions: April 5, 2021. Top three finalist will be notified that their design has made it to the next round of online voting. Please do not call regarding the selection process.

Deadline for voting online on the top three finalists: April 18, 2021

Selection of winner: April 19, 2021

Criteria for Selecting the Winning Design: the winning design will be determined by the creativity of the design and how well it incorporates the essence of Brandon's House as well as the walkathon theme. A panel of judges will select the three finalists to move forward in the competition (the director of Brandon's House, a local artist, and a teen representative). The winner will be determined by popular vote.

Prizes The winner will receive the following:

- One Walk 4 Teens shirt/hoodie
- One registration to the 2021 Brandon's House Walk 4 Teens.
- Recognition on the Brandon's House website, emails and social media.
- Listed as shirt designer on back of shirt with sponsors.

* The complimentary registration is non-transferable. If the selected winner is already registered for walkathon, they will be refunded their registration and shirt fees. If winner cannot be contacted within two days of selection, prize may be forfeited. Brandon's House reserves the right to use all designs for future marketing purposes. No reproduced images will be accepted. Your submission must be original artwork. There is no limit to the number of entries per person during the entry period.
