

NOTICE OF REQUEST FOR PROPOSALS

Notice is hereby given that New Albany-Floyd County School Corporation (“School”) is requesting proposals from qualified organizations to provide services for a School Age Child Care Program that, at a minimum, operates before and after the school day and may include periods when school is not otherwise in session at twelve New Albany Floyd County schools (Fairmont Elementary, Floyds Knobs Elementary, Georgetown Elementary, Grant Line Elementary, Green Valley Elementary, Greenville Elementary, Mt Tabor Elementary, S Ellen Jones Elementary, Slate Run Elementary, Hazelwood Middle, Highland Hills Middle, Scribner Middle) for the 2024-2025 school year (“Services”).

The proposals will be received until April 19, 2024, at 3:00 p.m. (EST) Proposals must be delivered to Tony Duffy, New Albany Floyd County Schools, 2813 Grant Line Rd, New Albany, IN 47150 and copy via email to tduffy@nafcs.org All proposals received after that time will not be considered and returned to that submitter.

Discussions may be conducted with, and best and final offers obtained from, responsible offerors submitting proposals determined to be reasonably susceptible of being selected for award. Contracts may be made with more than one offeror whose proposals are determined to be advantageous to School, taking into consideration price and other evaluation factors set forth in the Request for Proposals (RFP).

The RFP is on file at School’s administrative office and may also be accessed via <https://www.nafcs.k12.in.us/events/> All offerors must comply with the requirements of Ind. Code § 5-22 and as outlined in the RFP. Offerors must also be able to meet all requirements found in applicable licensing, public purchasing, and public contract statutes and regulations.

Prior to approval and execution of School’s contract(s), the responsible offeror who submits proposals determined to be reasonably susceptible of being selected for award must furnish satisfactory evidence showing evidence of financial responsibility, and it can faithfully perform the contract obligations.

School expects to award the contract(s) for the Products/Services at its June 10, 2024 Board meeting to the responsible offeror(s) whose proposal is determined in writing to be the most advantageous to School, taking into consideration price and the other evaluation factors set forth in the RFP. School reserves the right to hold proposals, including any alternates, for up to 30 days from the date of the opening. School reserves in its sole discretion the right to cancel the solicitation, reject any and all proposals in whole or part, delay the opening, ask for new proposals, is not obligated to accept the lowest or any other proposal, and may waive any irregularities, discrepancies, omissions, variances or informalities in the request for proposal procedure.
